Regulatory requirements for registered investment advisers and securities broker-dealers require that each have a business continuity plan (“BCP”) and disaster recovery procedures to address emergencies or other significant business interruptions. The SEC, FINRA, and CFTC conducted a study of the effects of Hurricane Sandy on several firms with a “significant market presence” and issued a report on common issues firms should consider when assessing their BCPs.
